Representative Schaefer served as the chair of the Texas House Freedom Caucus during the 85th Sessions of the Texas Legislature and led the caucus to secure and negotiate every Pro-Life victory in the House. Representative Schaefer filed House Bill 1971, a bill to close the fetal abnormality loophole from the 20-week abortion ban and promote Pro-Life options for children facing disabilities. He authored a similar policy as an amendment on Senate Bill 8. He also offered amendments that required stricter abortion reporting requirements on to House Bill 2962 and Senate Bill 8, the latter of which was signed into law. During budget negotiations, Representative Schaefer filed a Pro-Life amendment to defund abortion providers and their affiliates. Representative Schaefer is one of Texas Right to Life's 2017 Pro-Life Heroes.
