The only openly anti-Life Republican, Davis worked to deliver anti-Life victories. She voted against all Pro-Life bills during the regular and special sessions and supported and offered weakening and hostile amendments. In her role on a budget subcommittee, she would not increase funding for the Alternatives to Abortion program. She authored House Bill 1373, a bill that would allow abortifacient access to certain minors. She also authored an amendment to Senate Bill 8 that would have stripped nearly every Pro-Life provision from the bill. Also, when Representative Schaefer offered an amendment to protect preborn children with disabilities from painful abortions after 20 weeks, Davis opposed the life-saving amendment.

During the special session, Davis opposed all Pro-Life bills to protect the unborn as well as Senate Bill 11, the consensus bill to require patient consent before a physician can issue a Do-Not-Resuscitate Order. Davis is one of Texas Right to Life's 2017 Disappointments.

<b>X</b> Motion to Table Amendment 22 by Schaefer	Representative Schaefer offered an amendment supported by Texas Right to Life to close a loophole in current Pro-Life laws that allows preborn children with disabilities to be killed by abortion after 20 weeks of development. This motion to table was to kill Schaefer's amendment, demarcating loyalty to the Pro-Life cause or the anti-Life leadership of the Texas House. (Motion to Table Opposed by Texas Right to Life.)	0	6
