The Regular Session of the 88th Legislature marked the first opportunity for Texas lawmakers to pass Pro-Life bills after the historic overturning of *Roe v. Wade*. However, the Texas Legislature neglected preborn children, yet improved protections for vulnerable patients.

No bills passed to stop illegal abortions or fully enforce our Pro-Life laws. The Legislature underfunded pregnancy centers and adoption agencies but provided new help for pregnant and parenting college students. This session’s most notable victory was a reform to protect patients facing the anti-Life 10-Day Rule in the Texas Advance Directives Act. While there is still more work to do on this critical Pro-Life issue, this legislation is the most significant improvement in over two decades for patients’ rights and medical freedom in Texas.

Representative Vikki Goodwin authored several pieces of anti-Life legislation, including: House Bill 27, to block the civil enforcement tool of the Texas Heartbeat Act against an employer for provision of a particular employee benefit, namely paying for employee travel for out-of-state abortions; House Bill 1753, to establish a right to assisted reproductive technology; and, House Joint Resolution 62, a constitutional amendment establishing a right to “personal reproductive autonomy.” Despite several requests from Texas Right to Life, Representative Goodwin failed to coauthor seven of the Pro-Life Priority Bills that did not receive a vote on the chamber's floor. Coauthorship of a bill is important because it can help legislation move through the process and indicates the elected official's support when that bill doesn't receive a formal vote.
