The Regular Session of the 88th Legislature marked the first opportunity for Texas lawmakers to pass Pro-Life bills after the historic overturning of *Roe v. Wade*. However, the Texas Legislature neglected preborn children, yet improved protections for vulnerable patients.

No bills passed to stop illegal abortions or fully enforce our Pro-Life laws. The Legislature underfunded pregnancy centers and adoption agencies but provided new help for pregnant and parenting college students. This session's most notable victory was a reform to protect patients facing the anti-Life 10-Day Rule in the Texas Advance Directives Act. While there is still more work to do on this critical Pro-Life issue, this legislation is the most significant improvement in over two decades for patients' rights and medical freedom in Texas.

Representative Julie Johnson authored House Bill 2000, anti-Life legislation adding exceptions for rape and incest and to repeal Texas' pre-*Roe* Pro-Life laws. She spoke against passage of House Bill 17, which holds prosecutors accountable who are unwilling to pursue violations of Pro-Life laws. In her questioning, she incorrectly asserted that the bill could impede the free speech rights of prosecutors regarding abortion. Despite several requests from Texas Right to Life, Representative Johnson failed to coauthor seven of the Pro-Life Priority Bills that did not receive a vote on the chamber's floor. Coauthorship of a bill is important because it can help legislation move through the process and indicates the elected official's support when that bill doesn't receive a formal vote.
