The Regular Session of the 88<sup>th</sup> Legislature marked the first opportunity for Texas lawmakers to pass Pro-Life bills after the historic overturning of *Roe v. Wade*. However, the Texas Legislature neglected preborn children, yet improved protections for vulnerable patients.

No bills passed to stop illegal abortions or fully enforce our Pro-Life laws. The Legislature underfunded pregnancy centers and adoption agencies but provided new help for pregnant and parenting college students. This session's most notable victory was a reform to protect patients facing the anti-Life 10-Day Rule in the Texas Advance Directives Act. While there is still more work to do on this critical Pro-Life issue, this legislation is the most significant improvement in over two decades for patients' rights and medical freedom in Texas.

Representative Leach authored Pro-Life Priority House Bill 200, which would have reestablished the Prosecuting Attorneys Coordinating Council to oversee and hold accountable district attorneys who refuse to do their jobs. He also authored a Pro-Life amendment to Senate Bill 30, to increase the Alternatives to Abortion program budget by \$25 million over the remainder of the 2022-2023 biennium to meet the shortfall due to increased demand resulting from the Texas Heartbeat Act and the reversal of *Roe v. Wade*. Despite several requests from Texas Right to Life, Representative Leach failed to coauthor six of the Pro-Life Priority Bills that did not receive a vote on the chamber's floor. Coauthorship of a bill is important because it can help legislation move through the process and indicates the elected official's support when that bill doesn't receive a formal vote.
