The Regular Session of the 88th Legislature marked the first opportunity for Texas lawmakers to pass Pro-Life bills after the historic overturning of Roe v. Wade. However, the Texas Legislature neglected preborn children, yet improved protections for vulnerable patients.

No bills passed to stop illegal abortions or fully enforce our Pro-Life laws. The Legislature underfunded pregnancy centers and adoption agencies but provided new help for pregnant and parenting college students. This session's most notable victory was a reform to protect patients facing the anti-Life 10-Day Rule in the Texas Advance Directives Act. While there is still more work to do on this critical Pro-Life issue, this legislation is the most significant improvement in over two decades for patients' rights and medical freedom in Texas.

Representative Schatzline authored Pro-Life Priority House Bill 4138, establishing the Texas Adoption Assistance Program to help make adoption more affordable. He also introduced two Pro-Life amendments to House Bill 1. Both would have allocated funds to the newly-created Texas Adoption Assistance Program, contingent upon the passage of House Bill 4138. Unfortunately, neither of the amendments received a vote and House Bill 4138 did not pass. Representative Schatzline coauthored all the Pro-Life Priority Bills. Coauthorship of a bill is important because it can help legislation move through the process and indicates the elected official's support when that bill doesn't receive a formal vote.
