The Regular Session of the 88<sup>th</sup> Legislature marked the first opportunity for Texas lawmakers to pass Pro-Life bills after the historic overturning of Roe v. Wade. However, the Texas Legislature neglected preborn children, yet improved protections for vulnerable patients.

No bills passed to stop illegal abortions or fully enforce our Pro-Life laws. The Legislature underfunded pregnancy centers and adoption agencies but provided new help for pregnant and parenting college students. This session's most notable victory was a reform to protect patients facing the anti-Life 10-Day Rule in the Texas Advance Directives Act. While there is still more work to do on this critical Pro-Life issue, this legislation is the most significant improvement in over two decades for patients' rights and medical freedom in Texas.

Representative Toth authored Pro-Life Priority House Bill 4549, which would have authorized the Texas Attorney General to prosecute violations of Pro-Life laws when local prosecutors fail or refuse to do so within six months. He also authored Pro-Life Priority House Bill 2690, which would have held Internet service providers accountable to block Internet access to websites that distribute illegal abortion pills and add civil liability for these dangerous drugs. Representative Toth coauthored all the Pro-Life Priority Bills. Coauthorship of a bill is important because it can help legislation move through the process and indicates the elected official's support when that bill doesn't receive a formal vote.
