The Regular Session of the 88th Legislature marked the first opportunity for Texas lawmakers to pass Pro-Life bills after the historic overturning of Roe v. Wade. However, the Texas Legislature neglected preborn children, yet improved protections for vulnerable patients.

No bills passed to stop illegal abortions or fully enforce our Pro-Life laws. The Legislature underfunded pregnancy centers and adoption agencies but provided new help for pregnant and parenting college students. This session's most notable victory was a reform to protect patients facing the anti-Life 10-Day Rule in the Texas Advance Directives Act. While there is still more work to do on this critical Pro-Life issue, this legislation is the most significant improvement in over two decades for patients' rights and medical freedom in Texas.

Senator Alvarado authored two pieces of anti-Life legislation: Senate Bill 122, to add weakening exceptions to Texas' Pro-Life laws and to repeal Texas' pre-Roe abortion ban and Senate Bill 123, to add dangerous exceptions for a woman's mental health and a potential disability of a preborn child to Texas Pro-Life laws. Despite several requests from Texas Right to Life, Senator Alvarado failed to coauthor six of the Pro-Life Priority Bills that did not receive a vote on the chamber's floor. Coauthorship of a bill is important because it can help legislation move through the process and indicates the elected official's support when that bill doesn't receive a formal vote.

Senate Bill 412 by Senator Angela Paxton (R-McKinney):

Codify federal protections for pregnant and parenting college students into Texas law.
