The Regular Session of the 88<sup>th</sup> Legislature marked the first opportunity for Texas lawmakers to pass Pro-Life bills after the historic overturning of *Roe v. Wade*. However, the Texas Legislature neglected preborn children, yet improved protections for vulnerable patients.

No bills passed to stop illegal abortions or fully enforce our Pro-Life laws. The Legislature underfunded pregnancy centers and adoption agencies but provided new help for pregnant and parenting college students. This session's most notable victory was a reform to protect patients facing the anti-Life 10-Day Rule in the Texas Advance Directives Act. While there is still more work to do on this critical Pro-Life issue, this legislation is the most significant improvement in over two decades for patients' rights and medical freedom in Texas.

Senator Angela Paxton authored Pro-Life Priority Senate Bill 411, requiring higher education institutions to make A Woman's Right to Know Booklet available to college students. Senator Paxton also authored Pro-Life Priority Senate Bill 412, codifying federal protections for pregnant and parenting college students into Texas law. She also authored Pro-Life Priority Senate Bill 459, requiring higher education institutions that offer priority registration to provide this accommodation to pregnant and parenting college students. Despite several requests from Texas Right to Life, Senator Paxton failed to coauthor five of the Pro-Life Priority Bills that did not receive a vote on the chamber's floor. Coauthorship of a bill is important because it can help legislation move through the process and indicates the elected official's support when that bill doesn't receive a formal vote.

### Senate Bill 412 by Senator Angela Paxton (R-McKinney):

Codify federal protections for pregnant and parenting college students into Texas law.
