From the outset of the Regular Session of the 89th Texas Legislature, Texas Right to Life identified two key legislative priorities necessary to combat ongoing threats to Life in the post-Roe era. The first priority, the Woman and Child Protection Act (Senate Bill 2880 and House Bill 5510), addressed the growing problem of abortion pills being shipped into Texas. The second priority, the Stop Tax-Funded Abortion Travel Act (Senate Bill 33 and House Bill 1806), prohibited Texas cities from paying for out-of-state abortion travel. The Legislature successfully passed the Stop Tax-Funded Abortion Travel Act during the Regular Session. Unfortunately, the Woman and Child Protection Act, intended to combat the distribution of abortion pills, died in the House of Representatives, putting more than 19,000 preborn lives at risk each year.

Texas Right to Life formed and led a broad coalition to send a letter to Governor Greg Abbott, urging him to add this issue to the special session agenda. Because of the leadership of the Texas Senate and Governor Abbott, the Woman and Child Protection Act ultimately passed both chambers during the Second Special Session.

In addition, the Legislature passed several meaningful measures championed by Texas Right to Life that further strengthen our culture of Life. These victories include ensuring that families of preborn children diagnosed with life-threatening conditions receive life-affirming information and referrals, promoting education about adoption, and reaffirming protections for pregnant mothers facing medical emergencies. The Legislature also appropriated a record \$200 million to support qualifying pregnancy centers and adoption agencies, while clarifying that these funds must go exclusively to Pro-Life providers.

Representative Howard authored several pieces of anti-Life legislation. House Bill 257 would have removed the protection of Pro-Life laws for preborn children who potentially have a disability. House Bill 395 would have removed the protection of Pro-Life laws for preborn children if their mothers were victims of sexual assault. House Bill 2023 would have required insurance plans to cover abortifacient emergency contraceptives. House Bill 3668 would have required any additional Pro-Life laws passed by the 89th Legislature to be put up for a statewide election. Finally, House Resolution 236 memorialized former Planned Parenthood president Cecile Richards. On April 10, Representative

Howard gave an anti-Life speech on the House floor against an amendment to Senate Bill 1, stating her opposition to funding Pro-Life resources through the Thriving Texas Families program. On May 21, Representative Howard gave an anti-Life speech on the House floor opposing the passage of Pro-Life priority Senate Bill 33, which blocks Texas cities from funding abortion travel with tax dollars. On August 28, Representative Howard gave an anti-Life speech on the House floor opposing the passage of Pro-Life priority House Bill 7, which combats lethal abortion drugs being illegally transported into Texas. Representative Howard also authored a weakening amendment to Pro-Life Senate Bill 1233. The amendment failed.

## REGULAR SESSION

### **Senate Bill 1 by Senator Joan Huffman (R-Houston):**

The state's budget for Fiscal Years 2026–2027. The funding goal to meet increasing demands for Pro-Life resources was \$210 million dollars. The House achieved this goal, but the Senate reduced the amount to \$200 million when finalizing the budget.
