From the outset of the Regular Session of the 89th Texas Legislature, Texas Right to Life identified two key legislative priorities necessary to combat ongoing threats to Life in the post-*Roe* era. The first priority, the Woman and Child Protection Act (Senate Bill 2880 and House Bill 5510), addressed the growing problem of abortion pills being shipped into Texas. The second priority, the Stop Tax-Funded Abortion Travel Act (Senate Bill 33 and House Bill 1806), prohibited Texas cities from paying for out-of-state abortion travel. The Legislature successfully passed the Stop Tax-Funded Abortion Travel Act during the Regular Session. Unfortunately, the Woman and Child Protection Act, intended to combat the distribution of abortion pills, died in the House of Representatives, putting more than 19,000 preborn lives at risk each year.

Texas Right to Life formed and led a broad coalition to send a letter to Governor Greg Abbott, urging him to add this issue to the special session agenda. Because of the leadership of the Texas Senate and Governor Abbott, the Woman and Child Protection Act ultimately passed both chambers during the Second Special Session.

In addition, the Legislature passed several meaningful measures championed by Texas Right to Life that further strengthen our culture of Life. These victories include ensuring that families of preborn children diagnosed with life-threatening conditions receive life-affirming information and referrals, promoting education about adoption, and reaffirming protections for pregnant mothers facing medical emergencies. The Legislature also appropriated a record \$200 million to support qualifying pregnancy centers and adoption agencies, while clarifying that these funds must go exclusively to Pro-Life providers.

Representative Rodriguez Ramos authored multiple pieces of anti-Life legislation. House Bill 2586 would have established several targeted, burdensome restrictions on Pro-Life pregnancy resource centers. House Bill 3410 would have repealed Texas' Pro-Life laws that protect women and their babies from abortion, including the Texas Heartbeat Act, the Human Life Protection Act, the pre-*Roe* statutes, the Preborn Pain Act, and other medical regulations on abortionists. The bill also would have prohibited cities from enforcing local ordinances to protect women and children from abortion.

Representative Rodriguez Ramos also authored House Joint Resolution 80, an anti-Life constitutional amendment "guaranteeing the rights to an abortion and to assisted reproductive technology treatments and procedures, including in vitro fertilization." On August 28, Representative Rodriguez Ramos submitted anti-Life notes in the House journal on Pro-Life priority legislation House Bill 7, which combats lethal abortion pills being illegally shipped into Texas, stating that she was away from her desk in protest of the special session for the second and third readings, but would have voted against it each time.

#### **Senate Bill 1 by Senator Joan Huffman (R-Houston):**
