From the outset of the Regular Session of the 89th Texas Legislature, Texas Right to Life identified two key legislative priorities necessary to combat ongoing threats to Life in the post-Roe era. The first priority, the Woman and Child Protection Act (Senate Bill 2880 and House Bill 5510), addressed the growing problem of abortion pills being shipped into Texas. The second priority, the Stop Tax-Funded Abortion Travel Act (Senate Bill 33 and House Bill 1806), prohibited Texas cities from paying for out-of-state abortion travel. The Legislature successfully passed the Stop Tax-Funded Abortion Travel Act during the Regular Session. Unfortunately, the Woman and Child Protection Act, intended to combat the distribution of abortion pills, died in the House of Representatives, putting more than 19,000 preborn lives at risk each year.

Texas Right to Life formed and led a broad coalition to send a letter to Governor Greg Abbott, urging him to add this issue to the special session agenda. Because of the leadership of the Texas Senate and Governor Abbott, the Woman and Child Protection Act ultimately passed both chambers during the Second Special Session.

In addition, the Legislature passed several meaningful measures championed by Texas Right to Life that further strengthen our culture of Life. These victories include ensuring that families of preborn children diagnosed with life-threatening conditions receive life-affirming information and referrals, promoting education about adoption, and reaffirming protections for pregnant mothers facing medical emergencies. The Legislature also appropriated a record \$200 million to support qualifying pregnancy centers and adoption agencies, while clarifying that these funds must go exclusively to Pro-Life providers.

Senator Eckhardt authored several pieces of anti-Life legislation. Senate Bill 308 would have repealed Texas' Pro-Life laws protecting women and babies from abortion. Senate Bill 350 would have required health care providers to ignore the potential injury or death of the preborn baby when treating pregnant women. Senate Bill 359 would have required the state to pay for abortion, contraceptives, and sterilization. Senate Bill 360 would have allowed do-not-resuscitate orders to be placed on a pregnant woman, without regard to her preborn child. Senate Bill 1159 would have banned health care providers from sharing information about illegal abortions. Senate Bill 2961 would have prohibited wrongful death claims from being brought for the death of a preborn child killed by abortion. Finally, Senate Joint Resolution 20 proposed a constitutional amendment for abortion as a human right under "reproductive autonomy." On April 15, Senator Eckhardt gave an anti-Life speech on the Senate floor against Pro-Life priority Senate Bill 33, which blocks Texas cities from funding abortion travel with tax dollars. On April 29, she gave an anti-Life speech on the Senate floor on Senate Bill 31, which adds continued education for relevant medical providers and their advising attorneys regarding Pro-Life laws. On April 29 and 30, she gave an anti-Life speech on the Senate floor against Pro-Life priority Senate Bill 2880, which aimed to combat abortion pills being illegally shipped into Texas. On April 30, Senator Eckhardt entered an anti-Life note into the Senate journal opposing the passage of Pro-Life priority Senate Bill 2880, which aimed to combat abortion pills being illegally shipped into Texas.
